- 1. BSANA President Christina Maranci called the meeting to order at 12:15 p.m.
- 2. The Appointment of the Parliamentarian was completed and the meeting agenda was approved.
- 3. Necrology:

- 4. The Local Arrangements Committee of CUNY, Fordham, and Columbia Universities was thanked: Jenn Ball, Helen Evans, Eric Ivison, Holger Klein, Kostis Smyrlis, and Warren Woodfin for their efforts to welcome us to the conference. Thank you to Program Chair George Demacopoulos. A sustained round of applause followed.
- 5. Discussion and approval of the minutes from the Business Lunch of the XL Annual Byzantine Studies Conference (Simon Fraser University, Vancouver, British Columbia). The President invited discussion of the Minutes; none followed.

The motion to approve the minutes was made and seconded. The motion carried unanimously; no emendations were offered.

6. Election of four new members of the BSANA Governing Board

The Vice President (Teresa Shawcross) was called to the podium to announce the slate of nominees and their academic affiliation: Jenn Ball, CUNY; Darlene Brooks Hedstrom, Wittenberg University; Emmanuel Bourbouhakis, Princeton University; Bissera Pentcheva, Stanford University; Roland Betancourt, UC Irvine; Elena Boeck, DePaul University; and Elizabeth Williams, Dumbarton Oaks. Ballots were distributed on the tables, and the membership cast their ballots.

## 7. President's Report (Christina Maranci)

The President thanked the members of the Board, and especially those rotating off after four years of service: Alice-Mary Talbot, Vasileios Marinis, Warren Woodfin, and Scott Johnson.

Over the past year, BSANA was involved in a letter writing campaign supporting the Netherlands Institute in Turkey. BSANA also sponsored a reception at Kalamazoo together with the Mary Jaharis Center for Byzantine Art & Culture.

The president thanked the Mary Jaharis Foundation and the International Center for Medieval Art (ICMA) for sponsoring the conference coffees; the Mary Jaharis Foundation and the ICMA for sponsoring sessions at the 2015 BSC. Thanks were also offered to the Cloisters and the Metropolitan Museum of Art for their sponsorship and the Byzantine Evening. The Jaharis family underwrote the Business Lunch today.

## 8. Secretary's Report (Amy Papalexandrou)

## 9. Treasurer's Report (Scott Johnson)

The Treasurer's written report is incorporated by reference.

Scott Johnson reports that BSANA is in a healthy state financially. Membership is up (again). In addition, money is reserved in case of a notional collapse so that BSANA can continue. Donations from the membership are encouraged. He reports that Paypal worked well and he thanks the membership for embracing this new means of payment. He is cycling off as treasurer, with Christian Raffensberger taking over. (New Treasurer roundly applauded.)

Some remarks on the future of BSANA finances: Money is saved in some of the following (new) ways: Abstracts are no longer mailed; Keynote speaker expense doesn't extend beyond this BSC; Expenses are within our budget. It is possible to increase graduate stipends to \$500.

Future recommendations include publicizing member donations more actively, in addition to our membership fees. BSANA does not have endowments -- we operate solely on dues and donations from members.

The President thanked Scott Johnson for his two-year service; a warm applause followed.

10. Report from Dumbarton Oaks (Michael Maas, Rice University)

Greetings were extended from Dumbarton Oaks and Alice-Mary Talbot.

Ten fellows are currently in residence; nine summer fellows attended the coin/seal program under Vasso Penna. Visiting Fellows included Claudia Rapp (public lecture on Mt. Sinai), and Jonathan Shepherd in Spring.

11. Report from the Canadian Committee of Byzantinists (CCB)

Prepared by Geoffrey Greatrex (University of Ottowa), and delivered by Cecily Hillsdale (McGill University): Hilsdale reports that the newsletter will be out in January; all other activities are available on the CCB website.

12. Report from the United States National Committee for Byzantine Studies (USNCBS) (Charles Barber, Princeton University).

An update on preparations for the 23rd International Byzantine Congress (Belgrade) was provided. Report on the website, language routes (French, English, and Serbian), program, registration/submission guidelines and accommodation promised. Fees for the conference are 120 Euro if before December 1st. The Serbian Committee will send updates. National committees will be invited to send a proposal if they wish to host.
