- 8. Report from the United States National Committee for Byzantine Studies (USNCBS) (Alicia Walker)
  - 1. Intercongress Meeting: Sept 21-23, 2018 in Athens

a) Discussion of Plans for the 2021 Congress in Istanbul are progressing, and the details are on the website.

b) July 15, 2020 will be deadline for Free Panels for Congress. Roundtables and Plenary Sessions were approved at the Intercongress meeting.

2. The USNCBS and the Congress

The US committee had 4 accepted. Those accepted were noted and will be notified. Those not accepted should resubmit. Participants will be restricted to two activities at Congress. Derek Krueger proposed that round tables be decoupled from plenary themes in future.

3. Other AIEB Topics

Progress on various series in Byzantine studies. The AIEB website has been entirely revamped, with new resources on the website. Traffic has increased, and there is particular emphasis on graduate students. This website will assist any national committee in creating a website. The dues raised from 200 euro to 250 euro for national committees.

4. The US National Committee and BSANA

The National Committee has been a standing committee of BSANA. According to the bylaws, when the funds are exhausted, financial responsibility for membership will transfer to BSANA – and the treasurer will take control. Costs average \$850/year, with an

additional \$2500 every five years for the USNCBS President to attend the Intercongress meeting. The current balance is approximately \$500.
