### \* Program Committee, Launching 2018 BSC

The abstract book is almost ready to print.

Here's a beginning report on program committee data re. conferences for the last 3 years, that I have from being president 2016/Cornell, program chair in 2017/Minn. and now program committee member in 2018/San Antonio.

\* 91 papers [accepted for presentation] San Antonio 2018 in 3 concurrent sessions, 91/120 submissions [CFP revised March 15 deadline, from original February 15 deadline]

\* 72 papers presented Minnesota 2017 in 3 concurrent sessions, 72/106 submissions [March 1 deadline] \* 60 papers presented Cornell 2016 in 2 concurrent sessions, 60/\_\_\_ submissions [April 1 deadline; I have written to 2016 BSC Chair Brenda Llewelyn and have asked on stats]

\* 93 papers presented NYC 2015 in 3 concurrent sessions, 93/\_\_\_\_ submissions [April 1 deadline; Jenn/a NYC members might be able to gather stats]

In Minnesota we tried for the first time the new session format and directions to speakers/chairs that we are using this year again [full directions attached]. Before 2017, there were no uniform standards or protocols.

### Timing

1. Each Speaker is allotted 20 minutes to deliver her/his spoken paper. Papers longer than 20 minutes will be cut off by the Session Chair, who will strictly monitor and enforce these parameters. Each 20-minute paper will

be followed by 10 minutes of questions and audience discussion, guided by the Session Chair. This final 10 minutes is not to be used for further reading of a paper that is too long. It is a time for dialogue and intellectual exchange between the audience and the speaker.

<u>re. CFP 2019-submission date, criteria for reviewing abstracts</u> Jenn has told me that at Board meeting/s she will weigh in on easychair use into future.

In 2018, the first CFP date I suggested and we first ran, February 15, was a failure. Your revised CFP date of March 15 was successful. To consider: does the Board want to go with March 15 as the submission due date for 2019? In 2017 the deadline was March 1, stats above.

The attached 2018 CFP document describes the criteria used by committee members for their reviews. Along with the rejection email, this language can be reviewed if the Board wishes to reframe/redefine what makes a successful abstract.

#### re. accepted papers dropping out

In 2017 at Minnesota I saw at least 5 people drop out for various reasons right before the 2017 BSC; I will try to determine whether closer to 10, the 2018 number Jenn is tallying.

#### re. BSC online survey and feedback on no Sunday

I will draft 2018 online survey tonight for you to share with Board ahead of time--I can tweak at conference and we can distribute Sunday. Attached is 2016 survey/results you can review in the meantime.

#### re. Jaharis funding for graduate student development

For the Board: Does BSANA want to continue the \$5200 annual Jaharis grant funding for graduate student development? Brandie said Jaharis happy to renew [original 3 yr agreement attached.] The two past annual reports are also included for 2016 and 2017.

### Memo

27 September 2017

To: Members of the BSANA Governing Board From: Georgia Frank (Class of 2017 member of the Governing Board)

#### Proposal:

To support the work of the nominating committee by implementing a public call for nominations (and selfnominations) process, starting in 2018. One idea might be to send an email would be sent out in late spring and late summer soliciting nominations.

#### Rationale:

The BSANA by-laws states that "9. The Nominating Committee ... is responsible for providing a slate of Governing Board candidates at the next annual BSANA Business Meeting, and <u>it will consult the membership</u> in its effort to maintain a balanced representation on the Board of different scholarly specialties and of different North American regions. "Currently, the Governing Board does not have a mechanism by which to gather nominations for future

leadership. We propose an annual call for nominations email be sent out to BSANA membership, as a way to provide the nominating committee with more nominees to consider and recruit. A call-for-nominations (and self-nominations) process would have the advantages of:

- 1) providing continuity between nominating committees (e.g., to remember those who declined but would like to be re-invited to the ballot),
- 2) give members a voice in shaping leadership and the field of Byzantine Studies
- 3) to help future nominating committees identify scholars interested in getting more involved in the organization
- 4) to generate a more inclusive pool reflective of BSANA's increasingly diverse membership.
- 5) To this end, I propose the call be emailed to BSANA membership (or listserv) in May and again August and posted on the the association's webpage.

SAMPLE DRAFT (adapted from the email sent to members of the North American Patristic Society) We write with a call for nominations for the BSANA's new slate of board members to serve until 20XX. The slate of nominees will be presented for your approval at our 20XX annual business meeting, to be held Saturday, DATE. Self-nominations and multiple nominations are welcome. Please send us your nominations by September 1, 20XX along with contact information and a couple of sentences detailing the reasons for your support of each nominee, including some mention of the nominee's involvement with the BSC.

We affirm that our academic community is strengthened through diversity and inclusion, and we strive for our governance, policies, use of resources, and programming to reflect our commitment to both.

\* "We would like to propose that you share this draft statement with the Board for discussion, at which point we would open it up for any edits, corrections, amendments, etc. If the Board is able to approve the statement, then we envision two possibilities for next steps. Either, we could present the statement to the society for comment, amendment, etc., and then vote on it at the business meeting. Or, we could present it at the business meeting, and give the society a year to comment, edit, etc., and then accept/reject it next year."
